**Faculty of History and Arts (09)**

---

**Supervision and examination eligibility:** All persons according to § 7 (1) sentence 1 no. 2 a), b), d) - g) PromO are entitled. As well as c) and i) only with the consent of the faculty council and doctoral committee or h) only with the consent of the doctoral committee (written application of the doctoral candidate, written statement of the desired supervisor). For all doctoral candidates accepted for doctoral studies up to three years before their supervisor retires, the retiring professor may continue to supervise them on an equal status with full-time professors (a) and provide the review on an equal status with them.

**Combination of reviewers:** A full-time professor (§ 7 (1) Sentence 1 No. 2 a) PromO) of Faculty 09 must be involved in the review. He/she should belong to the subject of the doctorate.

**Combination of the Examination Committee (disputation):** At least one member of the examination committee (examiners of the disputation) must be from a subject other than that of the doctoral subject. See § 13 (1) sentence 3 PromO.

**External second examiner / third examiner (disputation):** only with the approval of the Doctoral Committee (written application of the doctoral candidate, written statement of the supervisor, CV and publication list of the desired external person).

**Cumulative dissertations:** not possible.

---

**Faculty of Philosophy, Philosophy of Science and Religious Studies (10)**

---

**Supervision and examination eligibility:** All persons according to § 7 Para. 1 Sentence 1 No. 2 a), d) - g) PromO are entitled. As well as i), if in the position of head of a third-party funded project.

**Acceptance as a doctoral candidate:** already at the time of acceptance as a doctoral candidate, in the case of supervision by a non full-time professor (e. g. § 7 Para. 1 Sentence 1 No. 2 b) - i) PromO) the written consent to the second review by a full-time professor (a)) of the doctoral subject must be submitted. At the request of the first supervisor (and doctoral candidate), this full-time professor may delegate the second review in writing to a second reviewer from another subject area.

**Combination of reviewers:** A full-time professor (§ 7 (1) Sentence 1 No. 2 a) PromO) of Faculty 10 must be involved in the review. He/she should belong to the subject of the doctorate. Please note the regulations for acceptance as a doctoral candidate.

**External second examiner / third examiner (disputation):** only with the approval of the Doctoral Committee (written application of the doctoral candidate, written statement of the supervisor, CV and publication list of the desired external person).

**Cumulative dissertations:** only with the approval of the Faculty Council and the Doctoral Committee (written application of the doctoral candidate and written statement of the supervisor in each case). Not possible in the subject Philosophy.

**Faculty of Psychology and Educational Sciences (11)**

---

**Supervision and examination eligibility:** All persons according to § 7 (1) sentence 1 no. 2 a), b), d) - g) PromO are entitled. As well as c) and i) only with the approval of the faculty council and doctoral committee (written application of the doctoral candidate, written statement of the desired supervisor).

**Combination of reviewers:** A full-time professor (§ 7 (1) Sentence 1 No. 2 a) PromO) of Faculty 11 must be involved in the review. He/she should belong to the subject of the doctorate. Persons in status group d) are equal to group a) if an employment contract with the faculty exists.

**External second examiner / third examiner (disputation):** only with the approval of the Doctoral Committee (written application of the doctoral candidate, written statement of the supervisor, CV and publication list of the desired external person).

**Cumulative dissertations:** only with the approval of the Doctoral Committee (written application and written statement of the supervisor in each case).

---

**Faculty for the Study of Culture (12)**

---

**Supervision and examination eligibility:** All persons according to § 7 (1) sentence 1 no. 2 a), b), d) - g) PromO are entitled. As well as h) and i) only with the approval of the faculty council and doctoral committee (written application of the doctoral candidate, written statement of the desired supervisor).

**Combination of reviewers:** free combination of the persons named in § 7 (1) Sentence 1 a) - g) PromO.

**External second examiner / third examiner (disputation):** only with the approval of the Doctoral Committee (written application of the doctoral candidate, written statement of the supervisor, CV and publication list of the desired external person).

**Cumulative dissertations:** only with the approval of the Faculty Council and the Doctoral Committee (written application of the doctoral candidate and written statement of the supervisor in each case).

---

**Faculty of Languages and Literatures (13)**

---

**Supervision and examination eligibility:** All persons according to § 7 (1) sentence 1 no. 2 a), b), d) - g) PromO are entitled. As well as h) and i) only with the approval of the faculty council and doctoral committee (written application of the doctoral candidate, written statement of the desired supervisor).

**Combination of reviewers:** free combination of the persons named in § 7 (1) Sentence 1 a) - g) PromO.

**External second examiner / third examiner (disputation):** only with the approval of the Doctoral Committee (written application, written statement of the supervisor, CV and publication list of the desired external person).

**Cumulative dissertations:** only with the approval of the Faculty Council and the Doctoral Committee (written application and written statement of the supervisor in each case).
